3. Everyday cleaning of the site be ensured by the labour.
4. No eatables are permitted inside the court.
5. Repair work can be carried out on Holidays/ Saturdays/ Sundays and at night without any restriction.
6. Arera Club shall not be responsible for any delay in execution of the work. Any delay on part of the Contractor shall attract a penalty.
7. The Club will not provide any boarding, lodging to the workers and transportation will be at Contractor's cost.
8. Applicant must have a turnover of minimum Rs.20.00 lakhs for undertaking such types of jobs.
